Neither Dupuis Farm, Inc., nor its officers, directors, stockholders, agents or employees shall be liable to any injury or disability suffered by any horse, mare, or her offspring, from any cause whatsoever, while in the care, custody and control of Dupuis Farm, Inc., and the undersigned Owner and /or Agent specifically approves, consents and assents to this condition, and hereby waives and releases all and every claim for damages.

Service fee is due and payable when mare has a foal that can stand and nurse, or when the mare changes ownership, whichever occurs first. If full payment is not received within thirty (30) days from the date of invoice, a late payment penalty will be imposed in the amount of 1 1/2% per month compounded monthly on all balances over thirty (30) days.

All charges including veterinary fees, blacksmiths, transient breeding fees and board, must be settled before a mare is removed from the premises of Dupuis Farm Inc.

In the event that legal assistance should be required in order to collect service fees and/or board bills, the legal charges incurred by Dupuis Farm, Inc. must be borne by the customer. A live foal is one that can stand up and nurse.

This document certifies that the above designated mare is free of all infection and physically fit for breeding purposes, that such mare is not unmanageable or vicious and that such mare is represented on this application.

Persons acting as agents must file notarized letters of authorization from the owners stating that the agent is acting on their behalf and that said owner will be responsible for all expenses incurred. Failure to comply with this condition will impose personal and financial liability upon such agent with respect to all matters in connection with or arising out of this booking contract.
